The following details are also referenced in section N of your contract:

Insurance: Applicant/Lessee shall secure comprehensive general liability insurance with the coverage in the minimum amount of \$1,000,000 per occurrence/\$2,000,000 per aggregate; and liquor liability with a limit of \$1,000,000 in the event Applicant will be serving/selling alcohol, and such other insurance as may be reasonably required from time to time by Owner.

Such policy shall: (A) name Applicant/Lessee and the Named Insured; (B) Applicant/Lessee shall obtain an Acord certificate of liability insurance naming additional insured's as: Holman Ranch, LLC and its principals, members, managers, officers, servants, agents, contractors, employees and directors, and as to the limits set forth above. Applicant/Lessee agrees to waive all rights of subrogation against Owner; each insured and/or each of the Additional Insureds.

The insurance shall be issued by responsible insurance companies licensed to operate in the State of California

Any vendor not listed on our Preferred Vendors List must be approved in writing by Holman Ranch prior to contracting their services.

All vendors bringing compensated employees onto Holman Ranch property must carry worker's compensation insurance and provide proof of insurance to Holman Ranch no less than 30 days before the event.

Any vendor serving alcohol must carry liquor liability insurance and provide proof to Holman Ranch no less than 30 days before the event date.

In order to work at Holman Ranch, all vendors must carry current commercial general liability, sign and return the Vendor/Caterer Guidelines document, and abide by the property rules.
